#### EXHIBIT A

NewHold Investment Corp. (the "Company") was incorporated on January 24, 2020 and its activities for the period from inception through March 31, 2020 consisted only of the initial preparatory steps for a public offering that closed in August 2020. As such, it had no revenues and had incurred only \$2,000 of expenses for a net loss of \$2,000. No public or private warrants had been issued.

For the three months ended March 31, 2021, the Company anticipates reporting a net loss of \$4,082,000 due to the combined effects of \$1,456,000 in general and administrative expenses and the change in fair value of warrant liability expense of \$2,646,000.
